SINGTEL-UOB PLATINUM CARD TRANSFORM THE WAY YOU LIVE LUCKY DRAW 2008 TERMS AND CONDITIONS

1. Eligibility

- 1.1 Subject to Clause 1.2, the SINGTEL-UOB PLATINUM CARD TRANSFORM THE WAY YOU LIVE LUCKY DRAW (the "Lucky Draw") is open to all eligible principal cardmembers of SingTel-UOB Platinum Card (collectively "Principal Cardmembers" or each a "Principal Cardmember") which are valid, subsisting and in good standing as may be determined by United Overseas Bank Limited ("UOB) at its sole and absolute discretion, and are existing customers of good standing with SingTel (the "collectively Eligible Cardmembers").

 - d. Principal Cardmembers whose accounts are terminated between 10 November 2007 and the Draw Date (both dates inclusive);
 - e. persons who are or become insane, deceased, insolvent or have legal proceedings of any nature instituted against them; and

2. Qualifying Period

2.1 "Qualifying Period" for the Lucky Draw means the period 10 November 2007 to 31 January 2008 (both dates inclusive).

3. Draw Date

3.1 The Lucky Draw will be conducted on **5 March 2008** in the presence of UOB's internal auditors, or on such other dates as UOB may decide at its sole and absolute discretion ("the Draw Date").

4. Allocation of Lucky Draw Chances

4.1 One (1) Lucky Draw chance will be allocated to each Eligible Cardmember with every S\$50 charged during the Qualifying Period on his/her SingTel-UOB Platinum Card. Lucky Draw chances are allocated based on accumulative amount spent per month, rounded down to the nearest multiples of S\$50.

- 5.6 UOB may, at any time without notice in its sole and absolute discretion, substitute the Prize (including any component thereof) with another prize of similar value.

- 5.8 The winner will be notified by post and/or telephone based on the last known information on UOB records within two (2) weeks from the Draw Date.

6. General

- 6.2 Notwithstanding anything in these Terms and Conditions, UOB reserves the right at any time in its absolute discretion to determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions without prior notification, including but not limited to the eligibility terms and criteria, the selection of winners, and the timing of any act to be done, and all Eligible Cardmembers shall be bound by these amendments.
- 6.3 It is a condition precedent for participation in the Lucky Draw that the winner consents to the public disclosure of his/her name, identification/passport number and photographs for publicity or commercial purposes or otherwise participate in the publicity activities of UOB in relation to the Draw and to the use of any data provided by such winner for any future marketing effort by the UOB group of companies, without any payment or compensation thereof.

- 6.6 A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement.
