What wins top award at the 29th UOB Painting Of The Year Competition

Student's attempt to capture an artist's struggles during the creative process wins her top prize

SINGAPORE, 10 July 2010 – Many artists would have experienced a sense of loss and confusion when inspiration and ideas elude them at some point in their artistic careers. *What*, the top winning work of the 29th UOB Painting Of The Year (POY) Competition captures this poignant emotion.

The winner behind this piece of work is eighteen-year-old Bai TianYuan. She said," It is such a great honour to win the top award at the UOB POY. This is definitely something completely out of my expectation! Winning the top prize in Singapore's premier art competition will serve as an encouragement for me to pursue my passion in art making."

On her winning work, TianYuan added," 'What' was something I constantly asked myself throughout the decision-making process during painting. What was it that I wanted to express through this painting, what was the reason for painting this? So the question of 'What' accurately reflected my thought process. Art-making can be a rather painful process, when one has to come up with ideas significant and interesting enough to be worked on further, and to get those ideas conveyed effectively with meaningful compositions. It is not easy to make right choices in art, and sometimes one can be rather confused and at loss of what to do. My painting tried to depict this agonising state of mind."

Chief Judge Professor Robert Ely, a renowned arts and education consultant said, "What is a well executed canvas divided into three distinct parts: the darker, less focused background lying in the past; the promise of a painting in the future foreground; and the search for truth and inspiration in the present, expressed by the central figure. Every artist knows the tyranny of the blank canvas and the burning desire to find a way of filling that space with meaning and purpose.

Our wonderful city state of Singapore is changing, it is expressing itself in its art and in the

beauty of its recent buildings; informed, as it is, by our traditions and culture. The emerging

talents we witnessed in these works, particularly in our youth, is a promise waiting to be fulfilled.

There was no doubt in our minds that this was the painting of the year."

Gracing the prize presentation held at the Esplanade - Theatres on The Bay, Mrs Lim Hwee

Hua, Minister in Prime Minister's Office and Second Minister for Finance and Transport,

presented the prizes and certificates to the winners. UOB gave away more than \$100,000 in

cash prizes.

"Nurturing, attracting and developing creative talents are vital to Singapore's vision to become a

leading global city and a regional hub for culture and the arts. The UOB Painting of the Year

Competition has indeed grown over the years and has duly received recognition from the local

and international communities for its role in nurturing the next generation of artists and creative

leaders in Singapore," said Mrs Lim Hwee Hua.

Mr Wee Ee Cheong, Deputy Chairman and Chief Executive Officer, United Overseas Bank, and

Chairman of the UOB Art Committee said, "Through the years, we have seen the POY

submissions grow in terms of range, expression and medium. This year, for the first time ever,

UOB has also taken the Competition beyond Singapore. UOB (Thai) held the first UOB (Thai)

Painting Of The Year Competition in Bangkok in June. International platforms and cross-cultural

exchanges are important. They allow artists to obtain fresh ideas and learn from their peers. As
