- I. <u>Eligibility</u>
- 1. The UOB MasterCard Preferred Platinum Card Lucky Draw Promotion 2008 (the "**Promotion**") organized by United Overseas Bank Limited ("**UOB**") is open to all principal cardholders of UOB MasterCard Preferred Platinum Card.
- 2. The following persons are excluded from the Promotion: employees and immediate family members of UOB.
- II. General
- 1. The winners may be required to attend prize presentations and/or participate in publicity programmes which UOB may from time to time organize in connection with the Promotion and if so, such winners shall attend such functions. - 5. The Prize:
