



TERMS AND CONDITIONS FOR SINGTEL-UOB X SINGTEL SHOP CAMPAIGN

1. Promotion

- 1.1 This Singtel-UOB x Singtel Shop Campaign ("**Promotion**") is valid from 18 September 2023 to 31 December 2023, both dates inclusive (the "**Promotion Period**"). By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.2 This Promotion is open to all holders of a UOB Credit and Debit Card issued by United Overseas Bank Limited ("**UOB**") in Singapore (the "**UOB Credit Card**").
- 1.3 To participate in this Promotion, you must satisfy all of the following requirements:
- (a) successfully charge at least S\$350 in a single Eligible Transaction on your UOB Credit or Debit Card during the Promotion Period (the "**Qualifying Spend**"); and
 - (b) successfully register to participate in this Promotion during the Promotion Period by sending an SMS using your registered Singapore mobile number with UOB to 77862 in the following format: "**STXUOB**<space>**last 4 alpha-numeric characters of NRIC/passport**" (e.g. STXUOB 567A); and
- 1.4 For the purposes of this Promotion:
- (a) "**UOB Card**" refers to any personal Visa, MasterCard, American Express, Union Pay and JCB credit card or debit card issued by UOB in Singapore, but does not include any UOB Travel Account cards, UOB Corporate cards, UOB Purchasing cards, UOB Business cards, UOB multicurrency corporate and Private Label cards.
 - (b) "**Eligible Transactions**" means any retail transactions for the purchase of goods in-store at any of the physical Singtel Shops located in Singapore or via Singtel website.
 - (c) "**Excluded Transactions**" means transactions that are unposted, subsequently cancelled, voided or reversed for any reason, and/or any other transactions as may be prescribed by UOB from time to time.
- 1.5 For the avoidance of doubt:
- (a) UOB reserves the right at any time to amend the list of Eligible Transactions and the list of Excluded Transactions in its sole discretion and without any prior notice or giving any reasons.
 - (b) The Eligible Transactions charged by a principal holder of a Singtel-UOB Credit Card cannot be aggregated with the Eligible Transactions charged by the supplementary holder of that Singtel-UOB Credit Card for the purposes of computing any minimum spend requirement under this Promotion.
 - (c) A merchant's registered MCC may not always correspond with its nature of business. The MCCs are assigned by the merchant's acquiring bank. UOB does not determine the merchant's MCC. UOB shall not be liable in any way whatsoever relating to the categorisation of a merchant's MCC.

2. Cash Rebate



- 2.1 If you are amongst the first 500 customers each month of this Promotion to satisfy all the requirements in these Terms, you shall be eligible to receive Cash Rebate (as defined below) in accordance with the table set out below as your reward, according to your qualifying amount:

Spend Amount	If you pay with using

S\$350 – less than S\$800	S\$ 15	S\$ 30
S\$800 – less than S\$1,500	S\$ 25	S\$ 50
S\$1,500 and above	S\$ 35	S\$ 100

- 2.2 You are only eligible to receive the Cash Rebate once in this Promotion.
- 2.3 The maximum Cash Rebate that you may earn under this Promotion is capped at S\$100.
- 2.4 If you are eligible to receive the Cash Rebate, the Cash Rebate will be credited directly into your Card account by 31 March 2024 (or such other date as may be determined by UOB in its sole discretion).
- 2.5 The Cash Rebate can only be used to offset against payments for future transactions charged to your Card account.
- 2.6 The Cash Rebate is awarded on a first-come-first-served basis and is subject to availability. UOB shall not be required to update any participant on the availability of the Cash Rebate under this Promotion.
- 2.7 The Cash Rebate is non-transferable, non-assignable and not exchangeable for cash, credit or other goods and/or services whatsoever. UOB may substitute the Cash Rebate with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.8 For the avoidance of doubt, the account of your Card must be in good standing as determined by UOB at its absolute discretion. In the event that such account is delinquent, voluntarily or involuntarily suspended, cancelled, closed or terminated for any reason whatsoever before the Cash Rebate is credited into your account, the Cash Rebate shall be forfeited and you shall not be entitled any compensation or payment whatsoever.

3. General

- 3.1 The following persons shall not be eligible to participate in the Promotion:
- (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.



- 3.2 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Voucher or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third party applications, howsoever caused.
- 3.3 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 3.4 If UOB determines that you are ineligible to participate in this Promotion or to receive the Voucher, UOB may in its sole discretion forfeit the Voucher, reclaim the Voucher or charge to and debit an amount equal to the value of the Voucher from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the Voucher through such means as UOB may determine in its sole discretion.
- 3.5 The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.6 UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.7 Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.8 By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 3.9 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce the Terms.
- 3.10 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
