



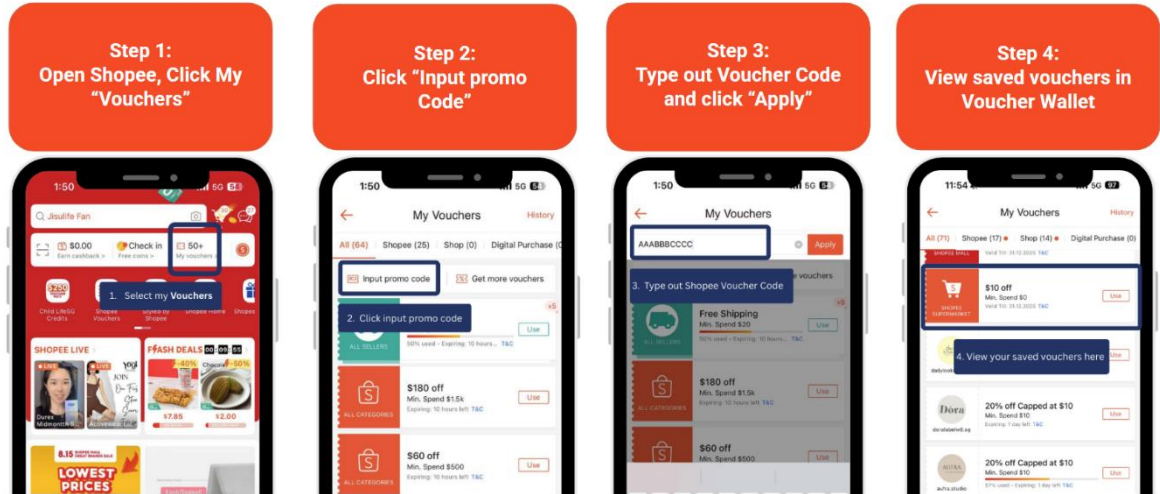
## Terms and Conditions for UOB Go Green Car Loan x Shopee Promotion for Tesla Electric Vehicle

1. The UOB Go Green Car Loan Promotion for Tesla Electric Vehicle (the “**Promotion**”) is valid from 1 April 2026 to 31 May 2026 or such date as may be determined by United Overseas Bank Limited (“**UOB**”) at its sole discretion (the “**Promotion Period**”).
2. You will qualify for this Promotion if:
  - (a) you have successfully applied for a UOB Go Green Car Loan during the Promotion Period to finance the purchase of new Tesla fully electric vehicle(s) (“**EV**”) whose definition is defined by Land Transport Authority (“**LTA**”) and/or Energy Market Authority (“**EMA**”) as Battery Electric Vehicles or “**BEV**” through any one of the car dealers on UOB’s panel of car dealers (the “**Application**”);
  - (b) your loan is approved and disbursed by UOB (“**Eligible Customers**”); and
  - (c) your Application has a minimum tenure of two (2) years and a minimum loan amount of S\$80,000.
3. This promotion is available to the first 50 Eligible Customers. Eligible Customers will enjoy S\$200 worth of e-Vouchers (in S\$50 denominator) provided by Shopee Singapore (the “**Voucher Set**”).
4. You will be notified via email within one (1) month from the date on which your loan approved under this Promotion is disbursed (or such other date as UOB may determine in its sole and absolute discretion) if you are eligible to receive the Voucher Set based on your email address in UOB’s records (the “**Email Notice**”). Each e-Voucher in the Voucher Set will be issued in the form of a code embedded in the Email Notice and you must follow the instructions set out in the Email Notice to redeem and use your e-Vouchers. UOB shall not be responsible or liable in any way to any person arising from your inability to redeem and use the e-Vouchers. No replacement will be issued for a lost, stolen or destroyed Email Notice.
5. The vouchers are only valid for the time period stipulated in your Email Notice (the “**Validity Period**”). No extension of the Validity Period will be permitted, and any e-Voucher not redeemed or used by the end of the Validity Period shall be forfeited.
6. Redemption and use of the e-Vouchers are subject to such terms and conditions and/or charges as may be imposed by Shopee Singapore at its sole discretion, and compliance with the same shall be your sole responsibility.
7. Voucher Sets are available on a first-come-first-served basis, whilst stocks last and subject to availability. UOB shall not be required to notify and/or update on the stock availability of the Voucher Sets.



8. Eligible Customer is required to download the **Shopee app** and register an account with Shopee for the utilization of the e-Vouchers – refer to steps below:

10. The Shopee e-Voucher is strictly non-transferable, non-substitutable or exchangeable for cash, credit or kind, in full or in part.
11. UOB may substitute the Shopee e-Voucher with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
12. This Promotion is not valid with other promotions unless otherwise expressly specified.
13. For avoidance of doubt, this Promotion does not apply to the UOB Car Loan (for purchase of non-electric vehicles) and UOB COE Car Loan.
14. UOB has the right at its sole discretion to approve or decline any Application and UOB shall not be required to give any reason or prior notice on any matter concerning such Application.
15. UOB assumes no liability or responsibility for any injury, loss, damage, charges, costs or expenses of any kind howsoever suffered or incurred as a result of or in connection with the redemption or usage of any reward/benefit under this Promotion or participation in this Promotion.





16. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with this Promotion (including, but not limited to, the eligibility to participate in this Promotion) at any time without prior notice or giving any reason or assuming any liability to any party whatsoever. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the reward/benefit through such means as UOB may determine in its sole discretion.

UOB may in its sole discretion, at any time and from time to time, vary or modify any of these terms and conditions, including but not limited to, terminating or withdrawing the Promotion or amending the duration of the Promotion, or the Promotion Period, or the eligibility criteria, without giving any reason, prior notice and/or assuming any liability to any party and UOB shall not be liable to pay any compensation or enter into any correspondence in connection with the same, and you shall be bound by these variations.

UOB's prevailing Standard Terms and Conditions Governing Banking Facilities, UOB's Standard Terms and Conditions for Hire Purchase Agreements (as may be amended, modified or supplemented from time to time) and any other product terms that may be applicable in connection with this Promotion (collectively, the "**Standard Terms**") shall continue to be binding on all Eligible Customers. In the event of any inconsistency between these terms and conditions and the Standard Terms, these terms and conditions shall prevail to the extent that such inconsistency relates to this Promotion.
