

UOB InsureDrive FairPrice Voucher Promotion (“Promotion”) Terms and Conditions

1. Promotion

- 1.1. This Promotion is jointly organised by United Overseas Bank Limited (“**UOB**”) and United Overseas Insurance Limited (“**UOI**”) (hereinafter collectively referred to as the “**Organiser**”).
- 1.2. This Promotion is valid from 1 July 2025 to 30 September 2025 (both dates inclusive), as may be extended by UOB in its sole discretion and without further notice from time to time (“**Promotion Period**”).
- 1.3. For the purposes of this Promotion:
- 1.3.1. “**Applicable Plan**” refers to InsureDrive Comprehensive insurance, which is underwritten by UOI and distributed by UOB.
- 1.3.2. “**Premium**” refers to the total insurance premium payable for the Applicable Plan.
- 1.3.3. “**Voucher**” refers to a shopping voucher given to eligible customers who satisfy the conditions under Clause 2.1.
- 1.3.4. “**Promotion URL**” refers to the website at [<https://online2.uoi.com.sg/epurchase/o2FUeOSDtA3cZCgEwSKLZ/workflows/>] where the Promotion is automatically applied to the purchase of an Applicable Plan and it is hosted publicly on [InsureDrive](#), and may also be accessed via the UOB website or UOB TMRW app.
- 1.4. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the “**Terms**”).

2. Promotion Mechanics

- 2.1. You shall be eligible to receive the Promotion (as described in the table below) on your Applicable Plan(s), if you satisfy the following conditions:
- 2.1.1. You must successfully pay your Premium for your Applicable Plan(s) during the Promotion Period.
- 2.1.2. Purchase the Applicable Plan(s) via the Promotion URL only.

UOB InsureDrive FairPrice Voucher Promotion (“Promotion”) Terms and Conditions

A customer purchases an Applicable Plan through the Promotion URL on 1 July 2025 and pays the Premium on the same day. The customer wants to start the Applicable Plan on 31 July 2025. For clarity, the start date of the Applicable Plan is the date of its inception.

- The Applicable Plan is considered as inceptioned on 31 July 2025. The Applicable Plan will have been inceptioned for 30 days on 30 August 2025 (i.e. 30 days from 31 July 2025).
- The Organiser will proceed to send the Voucher to the customer via SMS within 1 month after the Applicable Plan has been inceptioned for 30 days (i.e. within 1 month after 30 August 2025).
- At the point of purchase, a 10% discount will be automatically applied on the Premium payable by the customer.

- 2.2. The above discounts and Vouchers are not redeemable for cash, non-transferable and not valid with other promotions.
- 2.3. The Organiser may substitute the discount and Vouchers under this Promotion with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.4. The Vouchers must be utilized and redeemed by the expiry date stated within the Voucher Redemption Notice, otherwise the Vouchers will lapse. Strictly no extension or replacement will be allowed.
- 2.5. Redemption and/or use of any Voucher remain subject to such conditions as may be imposed by the merchant and/or suppliers of the Vouchers and you are solely responsible for complying with any such conditions at your own cost and expense.
- 2.6. The Vouchers are not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost, damaged or stolen.
- 2.7. The Vouchers are supplied by third party merchants and/or suppliers and the Organiser is not an agent of the merchant and/or suppliers of the Vouchers. Accordingly, the Organiser make no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Vouchers and assume no liability or responsibility for the acts or omissions of the merchants and/or suppliers or any non-performance or defects in the Vouchers. Any dispute regarding the Vouchers must be resolved directly with the merchant and/or supplier of the Vouchers. The Organiser shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier of the Vouchers. For the purposes of this clause, “**Vouchers**” include any products and/or services provided by third party merchants and/or suppliers in connection with the use and/or redemption of the Vouchers.

3. General

- 3.1 The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (b) anyone whom the Organiser may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 3.2 The Organiser will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of this Promotion. Without limiting the foregoing, the Organiser will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB’s online banking services or mobile banking services or third-party applications, howsoever caused.
- 3.3 The Organiser has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of

whether you have met all the requirements of the Promotion. The Organiser’s decisions shall be final, conclusive and binding and no payment or compensation will be given. The Organiser shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.

- 3.4 The Terms shall be read in conjunction with any other terms that may be relevant in connection with this Promotion (collectively the “**Standard Terms**”). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.5 The Organiser may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.6 Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.7 By participating in this Promotion and in addition to any other consent you have already provided to the Organiser and any right of the Organiser under applicable laws, you consent to the Organiser and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 3.8 Sending and receiving SMS is dependent on a SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by the Organiser for the Promotion and the Organiser shall not be responsible for any undelivered, lost or delayed SMS sent and/or received. You shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any SMS in connection with the Promotion.
- 3.9 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce the Terms.
- 3.10 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
