To redeem the Gift on your behalf, the authorised person must present all of the following at the redemption centre, at the time of redemption:

- A hardcopy of the original duly signed authorisation slip in the form set out in Annex 1 below
- A copy of your NRIC/Passport for verification purposes
- The authorised person's original NRIC/Passport for verification purposes

If any of the above documents are not presented at the time of redemption, the authorised person will not be entitled to redeem the Gift on your behalf.

TERMS AND CONDITIONS FOR THE REDEMPTION OF THE GIFT
