#UnitedasOneRedDot Campaign – Terms and Conditions

Instagram Photo Contest

- 1. Eligibility
- a. The #UnitedasOneRedDot Instagram Photo Contest ("IG Photo Contest") is open to all residents of Singapore aged 18 and above.
- b. The following persons shall not be eligible to participate in the IG Photo Contest:
 - i. Campaign organizers and planners
- c. Notwithstanding the foregoing, United Overseas Bank Limited ("UOB") has the absolute discretion to determine the eligibility of any person who is interested to participate in the IG Photo Contest. Such determination shall be final and conclusive and UOB shall not be obliged to give any reasons.

2. Contest Period

The IG Photo Contest will be held from 15 July 2025 to 12 August 2025 ("IG Contest Period").

3. Participation Criteria

- a. Participants must:
 - i. post a photo of themselves (with participant's face clearly visible) featuring a red or blue dot ball, mention @uobgroup, and include the hashtag #UnitedasOneRedDot ("IG Post");
 - ii. post the IG Post between 15 July 2025 and 10 August 2025 ("Eligible Period"); and
 - iii. either set the IG Post to public visibility, or if your profile is private, send us a screenshot of your IG Post via direct message,

(collectively "Eligible Entry").

b. There is no limit to the number of posts each participant may submit.

4. Winner Selection Process

- a. Between 15 July 2025 and 27 July 2025, one hundred and fifty (150) winners will be selected each week during the IG Contest Period. Winners will receive a notification from UOBGroup's official Instagram page on Tuesdays (22 July and 29 July 2025)
- b. Between 28 July 2025 and 10 August 2025, one hundred (100) winners will be selected each week during the IG Contest Period. Winners will receive a notification from UOBGroup's official Instagram page on Tuesdays (5 August and 12 August 2025).
- c. Winners will be chosen at random from all Eligible Entries.
- d. UOB's determination of the winners shall be final, conclusive and binding. No correspondence, appeals, or claims will be entertained. UOB reserves the right to disqualify or replace any winner who is subsequently found to be ineligible or in breach of any of the terms and conditions.
