If we fail to do so, you are authorized to forward the Second Beneficiary's invoices, draft(s) and other documents to the issuing bank or confirming bank, if any, without any responsibility or liability on your part
- (iv) Subject to the above, all our rights in the DC are transferred to the Second Beneficiary and the Second Beneficiary shall (up to the transfer amount) have the sole rights as the beneficiary of the DC.
- (v) Without any responsibility or liability on your part, you may forward the Documents, together with the Second Beneficiary's documents, to the issuing bank for payment, acceptance or approval at your sole discretion. We agree and acknowledge that you may effect payment to us and/or to the Second Beneficiary only upon your receipt of final payment from the issuing bank or confirming bank, if any.
